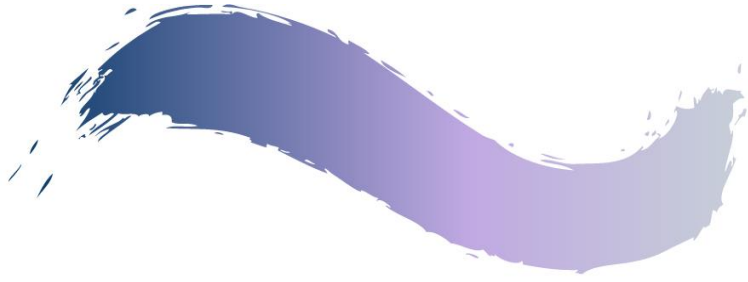

## INSTRUCTIONS TO STUDENTS

- 1) Details once uploaded cannot be changed under any circumstances. So extreme care should be taken while entering the data.
- 2) There is no upper limit for the number of scholarships that a student can apply.
- 3) No students are allowed to avail multiple scholarships other than Hindi scholarship, Snehapoorvam Scholarship, Urdu and Joseph Mundasserry Scholarship awards.
- 4) If a student selected for more than one scholarship, he/she must select one scholarship and has to cancel all others except Hindi scholarship, Snehapoorvam Scholarship, Urdu and Joseph Mundasserry Scholarship awards.
- 5) Students should keep track of the announcements regarding scholarships through the public addressing system/ scholarship websites/newspapers and act accordingly to avoid technical difficulties.
- 6) Students are directed to submit applications and the related documents demanded by the college office/scholarship wing in time. The college is not responsible for non-availability or cancellation of scholarship due to delayed or non-submission of documents/applications.
- 7) All scholarships will be disbursed only through the bank account of the students. So, the students are directed to open a Savings Account in any Nationalized Bank. In the case of 'Snehapoorvam Scholarship', the student should have a joint account with the guardian.
- 8) All scholarships except MGS (Muslim Girls Scholarship) and Snehapoorvam must be applied by the student during the first year degree program on time.
- 9) Selected students should renew their scholarships in the subsequent years (up to final PG)
- 10) All aspirants should have a valid AADHAAR.
- 11) Those who are having at least 75% of attendance are eligible for renewal.
- 12) Students are advised to go through the website concerned after the notification of each scholarship. There may be slight variations (last date of application, income limit, documents required etc.) in the procedure given in the handbook.
- 13) Students should remember their User ID and password for further usage

**1****POST MATRIC SCHOLARSHIP****OBJECTIVE**

The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

**SCOPE**

The scholarship is to be awarded for studies in India in a government or private higher secondary school/college/university, including such residential institutes of the Government and eligible private institutes selected and notified in a transparent manner by the State Government/Union Territory Administration concerned. It will also cover technical and vocational courses in Industrial Training Institutes/ Industrial Training Centres affiliated with the National Council for Vocational Training (NCVT) of classes XI and XII level.

**ELIGIBILITY**

Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian from all sources does not exceed Rs.2.00 lakh.

**DISTRIBUTION**

Muslim, Christian, Sikh, Buddhist, Jain and Zoroastrians (Parsis) have been notified as minority will Act, communities by 1992. made The on the distribution under basis Section of population scholarship 2 (c) of the National Commission for Minorities Act 1992. The distribution of scholarship among the States/Union Territories will be made on the basis of population of the above notified minorities in the States/ Union Territories of Census 2001.

**EARMARKING FOR GIRL STUDENTS**

30% of scholarship will be earmarked available, for girl students. balance In case earmarked sufficient number 30% of eligible scholarship girl students will be are not then the scholarships may be awarded to eligible boy students.

## **SELECTION PROCEDURE**

Unlike scholarship for SC and ST, there are a fixed number of scholarships for minorities is small and limited. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.

## **DURATION**

Scholarship will be provided for the entire course. However, maintenance allowance will be given for a period not exceeding 10 months only in an academic year.

## **RATE OF SCHOLARSHIP**

Actual financial assistance will be provided for admission & course / tuition fee and maintenance allowance as given below subject to a maximum ceiling indicated against item concerned:

## **IMPLEMENTING AGENCIES**

The scheme will be implemented through the State Government/ Union Territory Administration.

## **CONDITIONS FOR SCHOLARSHIP**

- I. Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian from all sources does not exceed Rs.2.00 lakh. Unlike scholarship for SC and ST, there are a fixed number of scholarships for minorities and hence preference for selection has been laid down. Students from BPL families, having the lowest income shall be given preference in the ascending order. The renewal applications would be fully exhausted before the new applications are considered.
- II. The award will be discontinued if a student fails to secure 50% marks or equivalent grade in the previous final examination. Scholarship will not be awarded for more than the normal period of time taken to obtain Certificate/Degree/M. Phil Degree/Doctorate Degree.
- III. Scholarships will not be given to more than two students in a family.
- IV. The students should be regular in attendance for which the yardstick will be decided by the competent authority of the school/college/university.
- V. Migration of students from one Institution to another would not normally be allowed during the course of the academic year except under exceptional circumstances and in the interest of the student's academic career.
- VI. If a student violates any other term and condition of the scholarship, the scholarship may be suspended or cancelled. The State Government/ Union Territory Administration can also directly cancel the award if duly satisfied of the reasons of violation of these regulations governing the scheme.
- VII. If a student is found to have obtained a scholarship by false statement/certificates, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid shall be recovered, at the discretion of the concerned State Government/Union Territory Administration.



- VIII. Course fee/tuition fee and maintenance allowance will be credited directly to the students' bank account.
- IX. The State Government/Union Territory Administration will maintain a separate account and records relating to the funds received from the Ministry and they will be subjected to inspection by the officers of the Ministry or any other agency designated by the Ministry.
- X. The student obtaining benefits under this scholarship scheme shall not be allowed to avail of benefits under any other scholarship scheme implemented by State Government/UT Administration, for the same purpose.
- XI. The State Government/ Union Territory Administration shall constitute a Committee of the departments implementing such scholarship schemes to ensure that the students from the minority community, who may also belong to SC/ST/OBC category, does not avail scholarship from other sources for the same purpose and avail only from one source.
- XII. The fund for distribution of scholarships in subsequent years will be released after receiving the utilization certificate for the previous year.
- XIII. The scheme will be evaluated at regular intervals by the Ministry or any other agency designated by the Ministry and the cost of the evaluation study will be borne by the Ministry under the provision of the scheme.
- XIV. The State/Union Territory shall place all relevant details of financial and physical achievements on their website.
- XV. The regulations can be changed at any time at the discretion of the Government of India.
- XVI. The concerned State Government/Union Territory Administration will be responsible for processing and scrutinizing the applications submitted by the students (as per the work flow opted) and send the proposal of eligible students online to this Ministry or sanction of the scholarships as per timeline

## RENEWAL OF SCHOLARSHIP

The scholarship, once awarded, may be renewed during the next academic year of the course on the production of certificate that the student has secured 50% marks in the examination.

## ANNOUNCEMENT OF SCHEME

The scheme will be announced by the concerned State Government/ Union Territory Administration well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media.

## PATTERN OF FINANCIAL ASSISTANCE

100% funding will be given by the Central Government to the State Government/Union Territory Administration.

## MONITORING & TRANSPARENCY

The States/Union Territories implementing the scheme shall monitor the financial and physical performance of the scheme at the State/Union Territory level. For this purpose, an IT enabled monitoring mechanism shall be in place. The State/Union Territory will be required to furnish quarterly financial and physical progress reports to the Ministry. The State/Union Territory shall maintain year-wise details of the students receiving scholarship, indicating school/college/institute, location of school/college/institute, government or private, class, gender and new or renewal. The States/Union Territories shall place relevant physical and financial details in their official website.

## EVALUATION

The monitoring of the financial and physical performance of the scheme will be evaluated by assigning evaluation/impact studies to reputed institutions/agencies by the Ministry of Minority Affairs, Government of India. PROCEDURE FOR APPLYING

- I. The scheme is implemented through National Scholarship Portal (NSP). It is mandatory for all students to apply online on the website of this Ministry i.e. [www.scholarships.gov.in](http://www.scholarships.gov.in).
- II. The list of documents to be scanned & uploaded for both Fresh and Renewal

### Scholarships as under:

- a) Student Photo (Mandatory).
- b) Institution Verification Form (Mandatory).
- c) Self declaration of Income Certificate by the student (Mandatory).
- d) Self declaration of community by the student (Mandatory).
- e) In case of Fresh: Self Attested Certificate of 'Previous Academic Marksheet' as filled in Form. (Mandatory).
- f) In case of Renewal: Self-Attested Certificate of Previous Year Mark sheet as filled in the Form (Mandatory).
- g) Fee Receipt of current course year (Mandatory).
- h) Proof of Bank Account in the name of student(Mandatory). 1) Aadhaar Card (optional).
- i) Residential Certificate (Mandatory).

**2****POST MATRIC SCHOLARSHIP FOR STUDENTS****OBJECTIVE**

The objective of the scheme is to award scholarships to meritorious students with disabilities belonging to economically weaker sections to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

**ELIGIBILITY**

Scholarship will be awarded to the students who have minimum 40% disabilities and the annual income of whose parents/guardian from all sources does not exceed Rs.2.5lakh. The religion of the applicant is not relevant to apply for this scholarship.

**PROCEDURE FOR APPLYING**

The scheme is implemented through National Scholarship Portal (NSP). It is mandatory for all students to apply online on the website of this Ministry i.e. [www.scholarships.gov.in](http://www.scholarships.gov.in).

**3****CENTRAL SECTOR SCHOLARSHIP****OBJECTIVE**

To provide financial assistance to meritorious students from low income families to meet a part of their day-to-day expenses while pursuing higher studies.

**SCOPE**

The scholarships are awarded on the basis of the results of Senior Secondary Examination. 82000 fresh scholarships per annum [41000 for boys and 41000 for girls] are awarded for pursuing graduate / postgraduate studies in colleges and universities and for professional courses, such as Medical, Engineering etc.

**ALLOCATION OF SCHOLARSHIPS**

The total number of scholarships are divided amongst the State Education Boards based on the State's population in the age group of 18-25 years, after segregating share of CBSE and ICSE on the basis of number of students passing out from various Boards in the country. 50 % of the scholarship is earmarked for girls. The number of scholarships allotted to a State Education Board is distributed amongst pass outs of the Science, Commerce and Humanities streams in the ratio of 3:2:1. In case of shortfall in the number of applications, the scholarship slots could be inter-changed.

**ELIGIBILITY**

Students who are above 80th percentile of successful candidates in the relevant stream from the respective Board of Examination in Class XII of 10+2 pattern or equivalent and pursuing regular courses (not correspondence or distance mode) in Colleges/Institutions recognized by All India Council of Technical Education, UGC Act, 1956, Medical Council of India, Dental Council of India and respective

regulatory authorities and not availing benefit of any other scholarship scheme including State run scholarship schemes/Fee waiver and reimbursement scheme are eligible under the scheme. Only those students who completed senior secondary examination in the preceding academic year are eligible. Students pursuing Diploma courses are not eligible under the scheme.

## RESERVATION

Students belonging to reserved categories/weaker sections /minorities are eligible on the basis of merit, subject to Central Reservation Policy and internal earmarking. Reservations for the various categories are as follows: Scheduled Castes (SCs) 15 %, Scheduled Tribes ( STs) 7.5 %, Other Backward Classes(OBCs) 27 % and horizontally 5 % for Physically Handicapped/ Persons(s)with Disabilities (PwDs) in all the categories.

## ANNOUNCEMENT OF THE SCHEME AND SELECTION PROCEDURE

- I. National Scholarship Portal (NSP) [www.scholarships.gov.in](http://www.scholarships.gov.in) will be opened for online application in the month of June-July every year.
- II. Class XII pass out students of the current Academic Year, who are above 80th percentile of the respective State Education Boards (SEBs) are eligible under the scheme and can apply on National Scholarship Portal ([www.scholarship.gov.in](http://www.scholarship.gov.in)), before the cut-off date. Physical application would not be accepted.
- III. The online applications would be verified at two levels:
  - 1) By the Institute where the student is studying.
  - 2) By the respective State Education Board.
- IV. Applicant is required to submit requisite documents, such as [Class 12th mark sheet, Income Certificate] to the Institute.
- V. Application which is not verified either by the institute or by the concerned State Education Board or by both will be treated as „ Invalid .
- VI. Merit list as per the State allocated quota would be generated from the verified applications.

## RATE OF SCHOLARSHIPS

The rate of scholarship is Rs.10000/- per annum at Graduation level for first three years of College and University courses and Rs.20000/- per annum at Post- Graduation level. Students pursuing professional courses, in case, where the duration of course is five (5) years/Integrated course would get Rs.20000/per annum in the 4th and 5th year. However, students pursuing technical courses such as B.Tech ., B.Engg would get scholarship up to graduation level.

## PARENTAL INCOME CEILING

The parental/family income ceiling is Rs. 8 lakh per annum for all categories under the scheme. Every year a fresh income certificate is not required.

## DURATION OF SCHOLARSHIPS AND ITS RENEWAL

A student will be eligible for the scholarship is renewable for a total duration basis not to exceeding year up to 5 Post years. Graduate A scholarship level in the under same the stream scheme (except for the students on year pursuing technical courses leading to degree at graduation level). The renewal will depend on:

1. Scholar securing 50 % or more marks in the preceding examination.

2. 75% attendance.
3. Not indulged in ragging activities.

If a scholar is unable to appear in the annual examination owing to illness and or on account of any unforeseen event, the award may be renewed for the next academic year on submission of medical certificate and other proof to satisfy the Head of the Institution who will certify that the student would have passed with 50% or more marks or equivalent Grade Point Average, had he/she appeared in the examination.

A scholar would be allowed to continue/renew his/her scholarship if, he/ she changes the course of study to a stream not offered by his school Board in Class XII (e.g. Law, Fashion Technology, etc.). Students changing their college/ institute of study would be allowed to continue/renew the scholarship provided the course of study and the institution is recognized.

For receiving scholarship benefit under Central Sector Scheme of Scholarship for College and University Students, an individual shall furnish proof of possession of Aadhaar or undergo Aadhaar authentication. Till the time Aadhaar is assigned to the individual, following alternative identifiers can be used:-

1. Aadhaar Enrolment ID slip
2. Application made for Aadhaar enrolment
3. Voter identity card
4. Permanent Account Number
5. Passport
6. Driving License
7. Certificate of identity having photo of such member issued by a Gazetted Officer or a Tehsildar on an official letter head;
8. Identity Card issued by the college or institute or university.
9. Any other document with photo specified by the State Government:

Further, the students are required to have the bank accounts opened, especially, in their name for availing the benefits under the scheme. The scholarship will be disbursed directly into the bank accounts of the beneficiaries through Direct Benefit Transfer (DBT) mode. The student can track their payment status from the template "Know Your Payment" in the Public Financial Management System (PFMS) portal [ <https://pfms.nic.in/Users/LoginDetails/Login.aspx>] either by indicating Aadhaar number or bank account number.

## **PROCEDURE FOR RENEWAL OF SCHOLARSHIP**

For students of Academic Year 2015 and onwards:

Students who have passed Class XII and have received fresh/renewal scholarship through the National Scholarship Portal (NSP) must apply online in the National Scholarship Portal ([www.scholarships.gov.in](http://www.scholarships.gov.in)) for the renewal scholarships.

For students of Academic Year prior to 2015:

Students who have passed Class XII prior to 2015, are required to obtain the renewal application blank form from the respective State Education Boards and submit the same duly certified from their respective institutions which is required to certify:

- a. that the student has secured 50 % or more marks in the previous exam,

- b. that the student has 75 % attendance and
- c. that the student is not involved in any ragging activities.

Renewal applications sent directly to the Ministry of Human Resource Development shall not be accepted.

## STATE MERIT SCHOLARSHIP

### Eligibility Conditions:

- Should be a first year student of Under Graduate or Post Graduate course in Govt./ Aided colleges or University Departments.
- Should have scored 50% or above in the qualifying Examination.
- Family annual income should not exceed 1 Lakh. For Exemption of annual income based on merit, please see the notification.

### Rate and Number of Scholarships:

- Graduation Rs. 1250/- per annum (300 Nos)
- Post-Graduation Rs. 1,500/- per annum (150 Nos.)

### Documents to be submitted to the Head of the Institution

- Self-attested passport size photograph pasted on from registration matriculation print out onwards.
- Attested copies of mark lists of all examinations
- Income certificate (Original)
- Nativity Certificate (Original)
- Attested copy of the first page of bank pass book in the name of student showing the account number and name, code and address of the branch.

### Duration:

Scholarship will be provided for the entire course

### Renewal of scholarship:

The scholarship, once awarded, may be renewed during the next academic year of the course on the production of certificate that the student has secured 45%marks in the examination.

### Announcement of scheme:

The scheme will be announced by the Government of Kerala well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media. Students will be informed about the scholarship by the college authority through the college public announcing system.

**Mode of application:**

Application can be submitted 'ONLINE' at the scholarship website of the Department of Collegiate Education, [www.dcescholarship.kerala.gov.in](http://www.dcescholarship.kerala.gov.in).

**Other Relevant Information**

- Applicants should have a Savings account in Nationalized/Scheduled/ of Jos Commercial banks.
- Scholarship amount will be credited to the Bank Account of the candidates selected. So Applicant should have a Bank Account in his/her name in any one of the above mentioned banks.
- The Aadhaar Number should be seeded with the Bank Account in which Scholarship Amount is desired to be transferred.
- Applicants should be a permanent resident in Kerala.

**5****MUSLIM GIRLS SCHOLARSHIP**

All girl students perusing first year UG/PG/Professional Courses belongs to Muslim/Latin Christian /Converted Christian category can apply for this scholarship. Those who failed to apply during the previous academic years can apply during the current year, without retrospective effect. Students staying in hostels owned by Government, Universities, IHRD, LBS or concerned institution are eligible for Hostel Stipend.

**Eligibility Conditions:**

- Should belong to Muslim, Latin, Converted Christian community and should be a native of Kerala.
- Should be a GIRL student studying for the first year of Graduation or higher courses in Govt. / Aided Institution.
- Students who got admission to Self-financing colleges from merit seat are also eligible to apply for this scholarship.
- Should have scored 50% or above in the qualifying Examination.
- Family Annual income should not exceed 8 Lakhs.
- Those who apply for Hostel stipend should be staying in recognized hostels.

**Rate and Number of Scholarships:**

- Row Under Graduates: Rs. 5,000/- per annum (3,000 Nos).
- Post Graduates: Rs. 6,000/- per annum (1,000 Nos).
- Professional Courses: Rs. 7,000/- per annum (1,000 Nos).
- Hostel Stipend: Rs. 13,000/- per annum (2,000 Nos).

**Duration**

Scholarship will be provided for the entire course.

**Renewal of scholarship:**

The scholarship, once awarded, may be renewed during the next academic year of the course on the production of certificate that the student has secured 50% marks in the examination.

**Announcement of scheme:**

The scheme will be announced by the Government of Kerala well in time, through advertisements in the leading language newspapers and local dailies and by using other suitable publicity media. Students will be informed about the scholarship by the college authority through the college public announcing system.

**Mode of application:**

Application can be submitted 'ONLINE' at the scholarship website of the Minority and Welfare, [www.minoritywelfare.kerala.gov.in](http://www.minoritywelfare.kerala.gov.in)

**Documents to be submitted to the Head of the Institution**

- Self-attested passport size photograph pasted on registration printout.
- Attested copies of mark lists of all examinations from matriculation onwards.
- Income certificate (Original) issued by the Village Officer concerned.
- Copy of Aadhaar card/NPR card.
- Copy of Nativity Certificate duly attested by a Gazetted officer.
- Copy of Community /Minority Certificate duly attested by a Gazetted officer.
- Attested copy of the first page of bank pass book in the name of student showing the account number and name, code and address of the branch.
- Inmate certificate from hostel warden counter signed by the Principal/Head of the Institution.
- Government allotment memo if the student studies for self-financing course.

**Other Relevant Information**

- Those who are eligible for hostel stipend will not be eligible for scholarship.

**6****BLIND/PH SCHOLARSHIP****Eligibility Conditions**

Blind/PH/Deaf students studying in Govt./Aided Arts and Science Colleges, Music Colleges, and Govt./Aided Higher Secondary/Vocational Higher Secondary Schools

**Financial Support**

- Fee Charges for Blind students with family annual income below Rs. 2.50 lakhs.
- Hostel charges for all PH students who are hostellers and whose family annual income is below Rs. 4.5 lakhs.

- The host institution where the candidate is studying is required to verify the online application.
- It is expected from the institutions where student has taken admission in the first year PG course, no tuition fees will be charged by the institute from girl students to pursue PG degree course in Universities/Colleges/Institutions

**Selection Procedure**

- 3,000 fresh scholarships will be awarded every year.
- The awardee can avail of other scholarship also during the tenure of this scholarship.

**Renewals**

- The scholarship will be renewed for the next year of study on receipt of renewal.
- Students failing to get promoted to the next class/ level would forfeit the scholarship.
- Change in course of study will not be permitted.
- The awardees of previous years will continue to follow the pattern of assistance through UGC/Canara Bank portal.
